2. Our said child SHALL at all times hereafter, in all records, deeds, documents and other writings, in all actions and proceedings, and in all dealings and transactions, public as well as private, and upon all occasions whatsoever, use and sign the name [CHILD'S NEW NAME] as our said child's name in substitution for our said child's former name so renounced.
3. We AUTHORISE AND REQUIRE all persons whatsoever at all times to designate, describe and address our said child by the adopted name [CHILD'S NEW NAME] only.
